AFFIDAVIT OF CALVIN DENNIE

I, Calvin Dennie, being duly sworn, depose and say:

1. I am available to testify under oath to the facts alleged below, should an evidentiary hearing be scheduled. My address is CDI Investigations, P.O. Box 10982 St. Pete, Florida 33733. My telephone number is (727) 430-2293.

2. I am a private investigator and the owner of CDI Investigations in St. Petersburg Florida.

3. On March 20, 2012, I was contacted by Lynn Marie Carty, who requested that I locate and interview an individual named Robert Milton Foster who was possibly located at 813 California Street, Tallahassee.

4. On March, 26, 2012, I arrived at the 813 California Street address and, after speaking to several individuals, found a black male, approximately 6'1" in height, weighing approximately 170 pounds who said that he was Robert Milton Foster, born July 31, 1949. I confirmed his identification by examining his prison identification card, which Mr. Foster provided me voluntarily. I also took photographs of Mr. Foster and briefly put him on the phone with Ms. Lynn Marie.

5. Mr. Foster told me that he was recently released from Cross City Correctional Institution in 2010. Mr. Foster also noted that he had been arrested in Pinellas County Florida in 1979 for aggravated assault and grand larceny.

6. He then stopped speaking to me and informed me that he had to leave to get something to eat.

7. Later that day, I continued my conversation with Mr. Foster.


8. I asked him how long he lived at 813 California Street #1 address and he told me that he moved there in 2004, but left when he was arrested in 2006 for sale and possession of cocaine. After he served time for this arrest, he returned to the 817 California Street #3 address.

9. Mr. Foster also confirmed that, after being released from prison in 1975, he returned to Orange County, Florida. He stated he had at one time worked as a migrant worker in Florida but didn't make any money at it.

10. During our conversation, people started to gather around me suspicious of my questioning of Foster and so, concerned with safety issues, I concluded the conversation and left the area.


Under penalty of perjury, I declare that I have read the foregoing affidavit and that the facts stated in it are true.
